## **Brief Project Description**

The Government of Democratic Republic of Timor-Leste has requested ADB financing for the consulting Service for the Design of remedial measures at locations to be rehabilitated along Manatuto – Laclubar – Natarbora Road.

# **Consulting Services**

Consultant is expected to have experience in the detailed engineering design of road projects. The consultant is further expected to have appropriate experience in providing consulting services for the implementation of road projects in a similar environment. Since knowledge of local conditions would be beneficial, international consulting firms are encouraged to associate with local companies or individuals with the relevant expertise.

Estimated time-input of key experts (International) is 16 person-months and estimated time-input of non-key experts (National) is 25 person-months. The Terms of Reference for the consulting services is attached for ready reference.

A consulting firm will be selected following Quality and Cost Based Selection (QCBS – 80:20) method in accordance with the <u>2013 Guidelines on the Use of Consultants by Asian Development Bank and its Borrowers</u>

Interested consulting firms must provide information indicating that they are qualified to perform the services. The consulting firms may associate with other international and national firms to enhance their qualifications.

The Consultant EOI shall demonstrate <u>technical competence</u>, <u>experience with multilateral Development Agencies</u> and <u>geographical experience</u> (Developing Countries in Particularly Asia Pacific) based on project references as well as <u>management competence</u>. Please select most relevant road design projects where the value of the Consultant's participation under each contract meets or exceeds **USD 350,000** and completed within **last 10 years** to demonstrate the firm's competence (<u>submission of maximum 10 projects</u>). The Consultant describes standard policies, procedures, and practices that your entity has to assure quality interaction with clients and outputs. Please state if your company is <u>ISO certified</u>.
